### Processing

The low viscosity of coatings and flooring systems based on Aradur® 42 facilities their application by normal means. If applied by two-component, heated spray equipment, care should be taken not to heat either component above 37.8°C (100°F).

#### Storage

**Aradur**<sup>®</sup> **42 Hardener** is supplied in 397 pound steel drums. It should be stored in a dry place, in the sealed original container, at temperatures between 2°C and 40°C (36°F and 104°F). The temperature should never be allowed to drop below 0°C. Under these storage conditions, the product has a shelf life of **3 years** (from date of manufacture). The product should not be exposed to direct sunlight.
